THE CLEAR EDUCATION SPECIALIST CREDENTIAL is available to individuals who hold a Preliminary or Level I Education Specialist Credential.

This program leads to completion of a Clear Education Specialist Credential with specialization areas in Deaf and Hard of Hearing, Early Childhood Special Education, Mild/Moderate Disabilities, or Moderate/Severe Disabilities. The Clear Credential must be completed within five years of the date of issuance of the Preliminary or Level I Education Specialist Credential.

The purpose of the Clear Credential Program is to provide a mechanism for the successful induction of a new professional special educator. This requires collaboration and shared responsibility among the candidates, university advisor, and Support Provider. In accordance with the Commission on Teacher Credentialing (CTC), the Clear Credential Program includes collaboration with the teacher's employer, multiple opportunities for support and professional development, an individualized induction plan (IIP), and advanced coursework with a menu of options to address the teacher's individual needs.

The emphasis of the program is to move special educators beyond the functional aspects of teaching to more advanced knowledge and reflective thinking about their role in providing effective instruction and an environment for student success. Research on teacher education indicates that a successful induction program supports teacher retention and improves job satisfaction. Procedures for admission are conducted through the Credential Office, ED 103.

The Clear Education Specialist Credential requires that the induction component be completed in a school setting. Each candidate, as part of admission to the Clear Education Specialist Credential Program, will submit a Verification of Employment Form. If a candidate is not employed, she or he will meet with a special education advisor in the appropriate specialization to discuss an education setting in which to complete IIP activities and demonstrate effective teaching. Upon approval of the setting by all parties, a Verification of Education Setting Form will be submitted as part of the admission process.

ADMISSION REQUIREMENTS FOR THE CLEAR CREDENTIAL

The minimum requirements for admission include:

1. Submission of a complete Clear Education Specialist Credential Admission Application Packet.
2. A valid Preliminary or Level I Education Specialist Credential.
3. Verification of employment as an Education Specialist
<http://www.csun.edu/education/cred/forms> or Verification of an Educational Setting form (for those not currently employed). You must meet with Dr. Kennedy to complete this form for the induction component of the program. Contact Dr. Kennedy at virginia.kennedy@csun.edu.
4. Application for Admission Form and Application Fee
The Application for Admission form is attached to this brochure. Only forms that are completed in their entirety, including the applicant's signature, will be accepted. Applicants must submit a \$25 application fee by Cashier's Check or Money Order made payable to CSU Northridge. Cash and personal checks cannot be accepted. Please include your CSUN ID number on the check.

Additional Items for applicants who have NOT completed a Preliminary or Level I Education Specialist Teaching Credential at CSU Northridge.

1. Statement of Professional Plans and Interest in this Program

On a separate sheet/s, please write a brief essay (no less than one single-spaced standard page and no more than five) in which you discuss how you have arrived at the decision to become a special education teacher, what you find most significant or rewarding about the role, what you find most challenging, and what you hope to gain from participation in the CSUN Clear Credential Program.

2. Two Letters of Recommendation

Two letters of reference/support are required for admission to this program. The letters should address your potential as a special education teacher and your potential for success in a graduate-level intensive credential program. It will be most useful if at least one of these letters is from a supervising teacher or administrator at the school in which you are currently employed. Other appropriate references are college or university faculty members who are familiar with your academic capabilities. Please request that your reference letters are sent to you so that you can submit them as part of your complete application package.

3. Transcripts from All Colleges/Universities, including CSUN

Transcripts from institutions other than CSUN must be official, in a sealed envelope and should be ordered directly from those institutions. Some institutions take as long as six weeks to send transcripts so do not delay. Arrange for all transcripts to be sent directly to you by the institution so that you can submit them as part of this package. Transcripts from CSUN may be unofficial. List all colleges/universities and years attended and attach all transcripts to the Transcripts form in this application. Grade slips and computer printouts are not acceptable.

Out of Country transcripts must have a detailed International Evaluation.

When the Selection, Admission, and Retention Committee reaches a decision regarding your admission based on review of materials, the Credential Office will notify you in writing via email.

All candidates must be admitted to (1) the university as a post-baccalaureate or graduate student, AND (2) the credential program. **NOTE:** Admission to the credential program does NOT constitute admission to the university. A separate application for admission to the University must also be submitted to the Office of Admissions and Records according to its application schedule if you are not currently enrolled at the University. Applicants seeking admission to a credential program should not enroll in Open University or The Roland Tseng College of Extended Learning. GENERAL INFORMATION

SPONSORSHIP AND GENERAL ADVISEMENT

Upon admission into the Clear Education Specialist Program, **and not before**, you should enroll in SPED 628, Induction and Formative Assessment.

A faculty member will provide advisement once you are enrolled in the SPED 628 Induction and Formative Assessment course. Candidates are only eligible for this course after having: (1) obtained a valid Preliminary or Level I Education Specialist Credential, (2) submitted a complete Clear Education Specialist application to the Credential Office, and (3) been admitted to the Clear Education Specialist Program.

Faculty members in the Department of Special Education provide all advisement for Clear Education Specialist Credential candidates. After receiving the formal admission letter from the Credential Office, contact the department office at (818) 677-2596 (Voice/TTY) to make an appointment for such advisement.

Master's programs in Special Education are available through the Department of Special Education. Should you plan to work concurrently for a Clear Education Specialist Credential and a Master's Degree, you must be admitted to the Master's Program in the area of your choice. Consult the Special Education Department and your advisor for further information.

If you hold a Preliminary or Level I based on an out-of-state or out-of-country teacher preparation program:

You may be required to complete additional state requirements to qualify for the Clear Education Specialist Credential. To meet with a credential advisor, please visit the Credential Office website for hours and availability at <http://www.csun.edu/education/cred>.

GPA AND RETENTION

Students must maintain an overall GPA of 2.75 since admission and a GPA of 3.0 in all Professional Education courses throughout the program. A grade of "C" or better is required in all coursework completed for the credential. Thus, if you receive a "C-" or lower in a particular course(s), that course(s) must be repeated. (Note: No more than two courses of Professional Education coursework may be repeated during your program. See below for further information.) In addition, you are responsible for all GPA requirements, course restrictions, prerequisites, and co-requisites listed in the CSUN University catalog, as well as this brochure.

REPEAT OF COURSES

With **prior** permission of the Clear Education Specialist Coordinator, Department Chair or Director of the Credential Office, and Associate Vice President of Graduate Studies, a graduate student may repeat, for the purpose of improving the grade, up to 6 units of credit in which a grade of "B-" or below (including a grade of "U") was achieved. In these cases only the most recent grade will count. Students must complete a Course Repeat Form (OGS 25) and obtain authorizing signatures prior to registering for the course to be repeated, per University policy.

CREDENTIAL REQUEST AT PROGRAM COMPLETION

Within the first few weeks of your final semester of fieldwork, you should submit a Credential Request to the Credential Office to be recommended to the Commission on Teacher Credentialing (CTC) for issuance of a Clear Education Specialist Credential. A Credential Analyst will complete an initial review and then hold your request until final requirements have been met.
